Under and by virtue of the authority vested in me by Title 5, Subtitle A, Chapter 143 of the Local Government Code, V.T.C.S., said chapter entitled "Municipal Civil Service", I do hereby temporarily suspend Detective James D. Furr from the San Antonio Police Department, without pay. This suspension is to be effective on this the 1st day of March, 2014, and is to end not more than thirty (30) days after the date of final disposition of the misdemeanor described below.

The misdemeanor referred to above was filed on or about August 12, 2013, in the County Court at Law of Hays County Texas under Cause No. 13-2138, charging Detective Furr with the offense of Driving While Intoxicated.

This temporary suspension is not intended to reflect an opinion on the merits of the above misdemeanor charge.

A copy of this temporary suspension order is being filed with the Fire Fighters' and Police Officers' Civil Service Commission.
