AGREED SUSPENSION

Gentlemen and Officer Leroy Medlin Jr.:

WHEREAS, Officer Leroy Medlin Jr., pursuant to Article XXVII, Section 2 of the Collective Bargaining Agreement by and between the City of San Antonio and the San Antonio Police Officers' Association, was served on May 10, 2014, with a ten-day contemplated suspension; and

WHEREAS, pursuant to said contract, Officer Medlin was given an opportunity to rebut those charges being brought against him to Police Chief William P. McManus; and

WHEREAS, said opportunity was exercised by Officer Medlin; and

WHEREAS, Officer Medlin and Chief McManus have agreed that the discipline in this matter shall be a ten-day suspension without pay; NOW THEREFORE:

The undersigned parties hereby enter into this suspension agreement wherein it is provided that Officer Medlin shall be suspended without pay from the San Antonio Police Department for a period of ten days, commencing on June 26, 2014, and ending on July 5, 2014. Upon successful completion of one year, from the date this suspension is signed, without an allegation of similar misconduct which is subsequently sustained, and upon application by Officer Medlin within two weeks of such date, and approval by the Chief of Police, this suspension shall be reduced to a five-day suspension, and five days' pay and benefits will be returned to Officer Medlin. Officer Medlin waives any rights to appeal this Agreed Suspension and agrees no administrative or judicial body shall have power to review this Agreed Suspension or alter the terms of this agreement.

Officer Medlin has violated Subsection C of Rule XIII of the City of San Antonio Fire Fighters' and Police Officers' Civil Service Commission Rules, said rules having been adopted on February 23, 1998, and thereafter from time to time amended, by the Fire Fighters' and Police Officers' Civil Service Commission as the Civil Service Rules for the Fire and Police Departments of the City of San Antonio. The particular civil service rules violated by Officer Medlin and grounds for suspension are as follows:

(12) Violation of an applicable fire or police department rule or special order.

The Rules and Regulations and Procedures of the San Antonio Police Department which Officer Medlin has violated are as follows:

PROCEDURE 601 – PRISONERS (.06) SEARCHING OF PRISONERS (A) Officers are responsible for conducting a search, not to include a strip search or body cavity search, of prisoners to remove all weapons, dangerous objects, contraband, or evidence. (.08) TRANSPORTING PRISONERS (M) Police Vehicles With Physical Barriers: (1) Police vehicles used primarily for transporting prisoners have physical barriers between the front and rear seats and may be used to transport a maximum of two (2) prisoners if there is only one officer. Both prisoners are secured in the rear seat with safety belts.

The factual basis for the instant disciplinary suspension is as follows:

On or about December 28, 2013, Officer Leroy Medlin, Jr. arrested Mr. Pablo Vasquez for traffic violations after detaining him during a traffic stop in the 800 block of Kirk Place. Officer Medlin placed Mr. Vasquez in the back seat of his patrol unit after performing a limited search of Mr. Vasquez' body. Officer Medlin failed to secure Mr. Vasquez in the back seat with a safety belt prior to transport in violation of SAPD procedure. Officer Medlin then transported Mr. Vasquez to the City Magistrate's Office located at 401 S. Frio Road for booking. Once Officer Medlin arrived at the Magistrate's Office, he turned Mr. Vasquez over to Detention Officer Brown. Officer Brown performed another search of Mr. Vasquez and found a loaded 9mm handgun inside Mr. Vasquez' pants. Officer Medlin had failed to remove the weapon from his prisoner Pablo Vasquez as required by SAPD procedure when he conducted his own search of Mr. Vasquez.
