AGREED SUSPENSION

Commissioners and Officer Adam Azua:

WHEREAS, Officer Adam Azua, pursuant to Article XXVIII, Section 2 of the Collective Bargaining Agreement by and between the City of San Antonio and the San Antonio Police Officers' Association, was served on January 13, 2016, with a thirty-day contemplated suspension; and

WHEREAS, pursuant to said contract, Officer Azua was given an opportunity to rebut those charges being brought against him to Police Chief William P. McManus; and

WHEREAS, said opportunity was exercised by Officer Azua; and

WHEREAS, Officer Azua and Chief McManus have agreed that the discipline in this matter shall be a thirty-day suspension without pay; NOW THEREFORE:

The undersigned parties hereby enter into this suspension agreement wherein it is provided that Officer Azua shall be suspended without pay from the San Antonio Police Department for a period of thirty days, commencing on March 16, 2016, and ending on April 14, 2016. Upon successful completion of one year, from the date this suspension is signed, without an allegation of similar misconduct which is subsequently sustained, and upon application by Officer Azua within two weeks of such date, and approval by the Chief of Police, this suspension shall be reduced to a fifteen-day suspension, and fifteen days' pay and benefits will be returned to Officer Azua. Officer Azua waives any rights to appeal this Agreed Suspension and agrees no administrative or judicial body shall have power to review this Agreed Suspension or alter the terms of this agreement.

Officer Azua has violated Subsection C of Rule XIII of the City of San Antonio Fire Fighters' and Police Officers' Civil Service Commission Rules, said rules having been adopted on February 23, 1998, and thereafter from time to time amended, by the Fire Fighters' and Police Officers' Civil Service Commission as the Civil Service Rules for the Fire and Police Departments of the City of San Antonio. The particular civil service rules violated by Officer Azua and grounds for suspension are as follows:

(12) Violation of an applicable fire or police department rule or special order.

The Rules and Regulations and Procedures of the San Antonio Police Department which Officer Azua has violated are as follows:

RULE 3.04 - RESPONSIBILITY TO SERVE THE PUBLIC: Members shall serve the public through direction, counseling, assistance, and protection of life and property. Members shall also respect the rights of individuals and perform their services with honesty, sincerity, courage, and sound judgment. (C) CONDUCT AND BEHAVIOR: Members, on-or off-duty, shall be governed by the ordinary and reasonable rules of good conduct and behavior, and shall not commit any act tending to bring reproach or discredit on themselves or the department.

The factual basis for the instant disciplinary suspension is as follows:

On or about August 30, 2015, Officer Adam Azua was at the Live Ultra Lounge located at 19314 US Highway 281 North. Officer Azua became involved in a disturbance with his girlfriend and a male patron, requiring intervention on the part of bar personnel/security at the bar. At some point, Officer Azua became physically combative, which resulted in him being subdued with a Taser and handcuffed by uniformed security personnel. This incident required on-duty SAPD resources to respond to the incident, which was handled under SAPD15186967. Officer Azua brought reproach and discredit upon himself and the department as a result of his conduct and behavior, which led to his eventual detention at the bar.
