AGREED SUSPENSION

Commissioners and Officer Daniel Groce:

WHEREAS, Officer Daniel Groce, pursuant to Article XXVII, Section 2 of the Collective-Bargaining Agreement by and between the City of San Antonio and the San Antonio Police Officers' Association, was served on May 31, 2015, with a one-day contemplated suspension; and

WHEREAS, pursuant to said contract, Officer Groce was given an opportunity to rebut those charges being brought against him to Police Chief Anthony L. Treviño, Jr.; and

WHEREAS, said opportunity was exercised by Officer Groce; and

WHEREAS, Officer Groce and his captain, David Scepanski, have agreed and Chief Treviño has approved of settling this matter with a one-day suspension without pay; NOW THEREFORE:

The undersigned parties hereby enter into this suspension agreement wherein it is provided that Officer Groce shall be suspended without pay from the San Antonio Police Department for a period of one day, commencing on July 3, 2015, and ending on July 3, 2015. Officer Groce waives any rights to appeal this Agreed Suspension and agrees no administrative or judicial body shall have power to review this Agreed Suspension or after the terms of this agreement.

Officer Groce has violated Subsection C of Rule XIII of the City of San Antonio Fire Fighters' and Police Officers' Civil Service Commission Rules, said rules having been adopted on February 23, 1998, and thereafter from time to time amended, by the Fire Fighters' and Police Officers' Civil Service Commission as the Civil Service Rules for the Fire and Police Departments of the City of San Antonio. The particular civil service rules violated by Officer Groce and grounds for suspension are as follows:

(12) Violation of an applicable fire or police department rule or special order.

The Rules and Regulations and Procedures of the San Antonio Police Department which Officer Groce has violated are as follows:

PROCEDURE 601 – PRISONERS (.06) SEARCHING OF PRISONERS (A) Officers are responsible for conducting a search, not to include a strip search or body cavity search, of prisoners to remove all weapons, dangerous objects, contraband, or evidence. (E) Transporting officers are held accountable for any prisoner arriving at a detention facility or processing room with a weapon, dangerous object, or contraband on his person.

The factual basis for the instant disciplinary suspension is as follows:

On or about April 13, 2015, Officer Daniel Groce transported a prisoner into the detention facility in case number SAPD15076953 without conducting a proper search of the prisoner. Crack cocaine was found in the prisoner's sock by the detention officer who searched the prisoner when he arrived at the facility.
