AGREED SUSPENSION

Commissioners and Officer Michael Alvarez:

WHEREAS, Officer Michael Alvarez, pursuant to Article XXVIII, Section 2 of the Collective Bargaining Agreement by and between the City of San Antonio and the San Antonio Police Officers' Association, was served on May 24, 2016, with a one-day contemplated suspension; and

WHEREAS, pursuant to said contract, Officer Alvarez was given an opportunity to rebut those charges being brought against him to Police Chief William P. McManus; and

WHEREAS, said opportunity was exercised by Officer Alvarez; and

WHEREAS, Officer Alvarez and his captain, John Saucedo, have agreed and Chief McManus has approved of settling this matter with a one-day suspension without pay; NOW THEREFORE:

The undersigned parties hereby enter into this suspension agreement wherein it is provided that Officer Alvarez shall be suspended without pay from the San Antonio Police Department for a period of one day, commencing on June 25, 2016, and ending on June 25, 2016. Officer Alvarez waives any rights to appeal this Agreed Suspension and agrees no administrative or judicial body shall have power to review this Agreed Suspension or alter the terms of this agreement.

Officer Alvarez has violated Subsection C of Rule XIII of the City of San Antonio Fire Fighters' and Police Officers' Civil Service Commission Rules, said rules having been adopted on February 23, 1998, and thereafter from time to time amended, by the Fire Fighters' and Police Officers' Civil Service Commission as the Civil Service Rules for the Fire and Police Departments of the City of San Antonio. The particular civil service rules violated by Officer Alvarez and grounds for suspension are as follows:

(12) Violation of an applicable fire or police department rule or special order.

The Rules and Regulations and Procedures of the San Antonio Police Department which Officer Alvarez has violated are as follows:

RULE 3.26 - TREATMENT OF PRISONERS: Prisoners shall be protected in their legal rights, given humane treatment, and shall not be subjected to verbal abuse or unnecessary physical violence.

PROCEDURE 601 – PRISONERS (.07) SECURITY OF PRISONERS – ESCAPE PREVENTION (F) If a prisoner escapes from an officer, the officer immediately notifies his supervisor and advises the Communications Unit of the description of the prisoner, the direction of travel, and the charges against the prisoner for broadcast to other field personnel.

The factual basis for the instant disciplinary suspension is as follows:

On or about March 29, 2016, Officer Michael Alvarez was dispatched to Castroville Road and S.W. 25th Street for a vehicle that crashed into a pole. Both of the occupants of the vehicle were placed under arrest. While Officer Alvarez was in his patrol car using the computer, one of the prisoners escaped and fled on foot. Officer Alvarez later apprehended the escaped prisoner, but failed to notify his supervisor or the Communications Unit of the escape. Officer Alvarez used abusive language towards him, stating "Don't fucking act up," and "If you do anything else, you're going to the fucking hospital..."

A copy of the instant disciplinary suspension order is being filed with the Fire Fighters' and Police Officers' Civil Service Commission.

I further acknowledge that in light of my entry into this Agreed Suspension, I shall have no right to appeal said suspension nor will any administrative or judicial body have power to review same or alter its terms. I do hereby waive any and all rights to appeal said suspension and no administrative or judicial body shall have power to review same or alter its terms.
