Specifically, the reason for this action is: On 10/29/2015, Patrol Supervisors were sent an email to schedule personnel for an EVO Awareness and Safety Course on November 23rd and 24th, 2015. You were scheduled to attend the class on November 23rd. A reminder was sent via email on 11/20, addressed to you, advising of the class set for the 23<sup>rd</sup>. On Monday, November 23rd, Deputy Highy advised that only (6) students were attending the class and sent the roster, to which you were not in attendance.

Upon speaking with Sgt. Davis later in the afternoon, you advised him that you got stuck in Austin and was unable to make it to the driving class. You also stated you contacted Lt. Colbert. You were also advised not to show up for the class on the 24th and you would be rescheduled. In speaking with Lt. Colbert, he states he has no record of speaking with you, nor does he have a record of you calling his county phone or personal phone.

Having additional paperwork to serve you, I contacted Sgt. Burchell prior to the start of your shift on the 23rd, to which he stated you would have been off due to attending driver training earlier that day. When he contacted you by phone, you had no intention of appearing for your shift.

Since you did not appear for training, you would have appeared for the start of you shift as required. Again, you had been told to not appear on the 24<sup>th</sup> for class. Tuesday, November 24<sup>th</sup> at 7:00am, I received a text forwarded by Sgt. Burchell reading: If I fill out a paper time off slip for personal time will you sign it, that way I'm taking the evo class on my own time. Sgt. Burchell indicated he received that text from you, but chose not to respond.

Although you were told by Sgt. Davis that you were not to show up for class on the 24<sup>th</sup>, you did so anyway. You sat in the class from 0830 to 0845 until removed by Captain Tijerina. Later that day, I was given a request for time off, written date submitted on 11/23/15 for personal leave that you left in Sgt. Burchell's box on the 24<sup>th</sup>. That request was disapproved.
