#### NOTICE OF PROPOSED SUSPENSION

You are hereby notified that the Bexar County Sheriff's Office is proposing to suspend you for Three (3) Days from the position of Law Enforcement Deputy.

You have violated the Bexar County Sheriff's Civil Service Rules, said rules having been adopted on March 14, 1985 and thereafter from time to time amended by the Bexar County Sheriff's Civil Service Commission. The particular Civil Service Rules violated by you are as follows:

#### SECTION 4. USE AND CONDUCT OF COUNTY OWNED PROPERTY

8.05 Intentional or negligent damage of County equipment or property will be grounds for disciplinary action or dismissal depending on the severity of the incident.

#### Chapter IX, Section 9.02:

- O. Conduct or action that would seriously impair job effectiveness.
- P. Conduct which has proven to be detrimental or has an adverse effect on the department

In addition, you have violated the following Bexar County Sheriff's Policies and Procedures:

# Specifically described below:

The Policies and Procedures of the Bexar County Sheriff's Office which you have violated are as follows:

#### 5.37B OPERATION OF COUNTY MOTOR VEHICLES

Each employee of this Department is charged with the responsibility of operating a county motor vehicle in a careful and prudent manner. Each employee shall obey all laws of the various municipalities, the State of Texas, and pertinent Department orders pertaining to operation of motor vehicles. No employee of this Department shall allow, at any time, any unauthorized person to operator a county owned motor vehicle or to have in their possession the keys to such motor vehicle.

13.03B Response to "Emergency" Calls

Vehicles shall be operated in a safe and prudent manner. Operators should be cognizant of their surroundings to include physical and climate conditions, traffic conditions, and potential actions of other drivers that could adversely affect the emergency response. Vehicles shall never be operated intentionally, knowingly, or recklessly in an unsafe manner.

The factual basis for the instant disciplinary action is as follows: On or about November 24, 2014, at approximately 0423 hours, while operating unit 8539, you state that you were assigned to a call and as you looked at your computer, you drifted to the left striking the concrete divider causing damage to both driver's side tires causing damage estimating at \$1,063.61. The Crash Review Board convened on December 12, 2014, and determined that this crash was preventable.

You will adhere to all Sheriff's Office policies and procedures cited above. In addition, you are to take the next available Remedial Driving Course. Be advised that your job performance will be monitored and further persistence in the behavior, which resulted in this Notice of Proposed Suspension, may result in a more serious disciplinary action, which may include dismissal from the Sheriff's Office.

You are advised that you may respond to this Notice of Proposed Suspension to the undersigned, in person or in writing, to explain or countervail said specific charges. Your written response, if submitted, must be received and time stamped by Sheriff's Administration no later than the fifth (5<sup>th</sup>) business day following receipt of this document.
