You had four inmates from one group out in the unit BC right side recreation yard and four inmates from another group out in the right side dayroom of unit BC. An inmate (Mario Saenz #709479) from the group of inmates out in dayroom informed you that an inmate (Frank Reyes #678932) who was out in the recreation yard had to go to the bathroom. Upon your opening of the recreation yard door, inmate George Rojas # 652746 was assaulted by the inmates that were in the recreation yard and the inmates that were out in the dayroom. The inmates in the dayroom should have secured first before allowing any inmate to come out of the recreation yard. Your actions placed the BCSO in liable situation. Your poor job performance and dereliction of duties will not be tolerated by the BCSO. Documentation: FIR# 020315-15.

The corrective action required: You will at all times be attentive with your duties to ensure that inmates under your direct supervision are not placed in situations where they may sustain serious bodily injury.
