NOTICE OF PROPOSED SUSPENSION

You are hereby notified that the Bexar County Sheriff's Office is proposing to suspend you without pay for a total of **FIFTEEN** (15) days from the position of Detention Officer for the violation of the following subsection(s) of Paragraph 9.02 of the Rules for the Bexar County Sheriff's Civil Service Commission:

J. Poor Job Performance

In addition to the following violation of the Bexar County Sheriff's Office Manual and Detention Manual of Policy and Procedure, Paragraph(s):

5.02 Performance of Duties, and 6.02 Alertness. BC No. 900.08-07, Contraband Prohibited in the Secure Area; Section IV-10

The specific reason(s) for this action: On Monday, October 10, 2016, your failure to properly secure your personal cellular telephone resulted in a security breach. At approximately 1345 hours an officer relieved you for a restroom break and discovered your personal cell phone inside the desk drawer of living unit 4B and reported the incident to your immediate Supervisor, Sergeant Bradley Gustin. Sergeant Gustin had the officer deliver the phone to him in corridor 125. You indicated in your report ADCA101016-20 that you "brought the cell phone into the jail because I don't have transportation to get back and forth to work. And I don't have a locker to put my cell phone in." Such conduct and disregard for security will not be tolerated.

The corrective action required: In the future, you will ensure that you properly secure any unauthorized items prior to entering the secured area of the Bexar County Adult Detention Center. Secondly, you are to remain alert and attentive to your duties and notify your supervisors of special circumstances; however, you shall not bring unauthorized items into the secured area. Furthermore, you will comply with Paragraph 5.02 of the Bexar County Sheriff's Office Manual of Policy and Procedure which states in part that "An employee shall not perform their job assignments ... by failing to exercise diligence, proper demeanor, intelligence and interest in the pursuit of their duties." Be advised that persistence of your apathetic behavior which resulted in this Notice of Proposed Suspension will result in more serious disciplinary action, which may include dismissal from the Sheriff's Office.
