You are hereby notified that the Bexar County Sheriff's Office is proposing to suspend you without pay for a total of five (5) days from the position of Detention Officer for the violation of the following subsection(s) of Paragraph 9.02 of the Rules for the Bexar County Sheriff's Civil Service Commission:

J. Poor job performance

O. Conduct or action that would seriously impair job effectiveness

P. Conduct which has proven to be detrimental or has an adverse effect of the Sheriff's Office

## 5.02 Performance of Duties

The specific reason(s) for this action: On Tuesday, May 13, 2014, you were assigned to the Inside Court Desk of the Bexar County Adult Detention Center's Booking area, located at 200 N Comal San Antonio, Texas. You prepared the rider for Inmate Jesse Garcia's, SID#694675 release. The court directive dated May 13, 2014 from D290th Judge Melissa Skinner indicated Inmate Garcia was continued on probation with a 30 day sanction to remain in BCADC. The order also indicated "credit for time served" with 23 days credit. In the report you submitted on this incident, you in fact indicated, that you read the directive and placed your initials in four (4) different places. You stated you generated a worksheet to calculate the days remaining on the sentence but you placed the wrong information, resulting in a release date as of 05-05-14.

If you had correctly placed the right information, the release date would have been 05-20-14. There was no worksheet attached to the rider as to indicate the correct calculation. The rider was prepared and passed over to the Release Desk, where Deputy Bravo #1132 released and dropped Inmate Garcia from CJIS at 1244hrs thus affecting a chain of events, which ultimately resulted with the early release of Jesse Garcia from the Bexar County Adult Detention Center.
