On Monday, August 10, 2015 10:25 AM, an email was received from DC Tammy Burr advising that CC2 had made several attempts to contact you regarding an upcoming trial date, to no avail. As of Monday, August 10, 2015 5:06 PM, still no contact was made. Notification to you via email had been made on Sunday, August 02, 2015 10:30 AM and Sunday, August 02, 2015 10:34 AM, advising of the upcoming trial date of 08:00 AM, Mon, Aug 10, 2015.

On Tuesday, August 11, 2015 3:56 PM, an email was received from DC Tammy Burr advising that CC5 was requesting your appearance for Thursday, 8/13/2015 at 10:30am. In that email, the ADA advised that this was a reset due to you failing to appear on a previous date. It was also noted that failure to appear will result in a forced dismissal of the case.
