

Notice of Proposed Suspension

EMPLOYEE: Deputy John Soto, 1st Detail, Main Jail

DATE: Tuesday, May 28, 2013

You are hereby notified that the Bexar County Sheriff's Office proposes to suspend you without pay for a total of 3 days from the position of Detention Officer for violation of the following subsections(s) of Paragraph 9.02 of the Rules of the Bexar County Sheriff's Civil Service Commission:

- C. Insubordination Unwilling to submit to authority
- O. Conduct or action that would seriously impair job effectiveness
- P. Conduct which has proven to be detrimental or has an adverse affect on the department

And violation of the Bexar County Sheriff's Manual of Policy and Procedures, Detention Manual of Policy and Procedures subsection(s)

5.03 Obedience

The specific reason(s) for this action: On Wednesday, May 22, 2013 you were at Mandatory in service training which was to run through Friday, May 24, 2013. On Wednesday, May 22, 2013 you were summoned from your in service training to attend a disciplinary hearing with Deputy Chief Thomas (BCSO Jail Administrator). During the hearing you were observed by Chief Thomas to be wearing shorts. After the hearing you were instructed by Chief Thomas to go home and change your attire (shorts) and return to the academy to resume in service training.

On Thursday, May 23, 2013, you called the Shift Commander's office to inquire form Deputy Albert Martinez #2755 about rescheduling your in service training due to the interruption of your training for a disciplinary hearing. Upon notification of your call I then called you at home and asked you why you were not at in service. You replied that you figured in service training for you was interrupted by the hearing; therefore, you needed to have our office to reschedule your training. I then ordered you to return to work and submit a written report to explain your failure instructed you to return to your scheduled mandatory training. You stated in your report that you returned to the academy and noticed that your class was out to lunch so you then decided to go home without authorization. Such conduct and insubordinate behavior will not be tolerated by the Bexar County Sheriff's Office.

Other persons who have knowledge of this incident include: Chief Mark Thomas, Albert Martinez, and Maria Fuentes.

Corrective Action Required: In the future, you will obey all lawful verbal or written orders emanating from uniform staff with rank. Furthermore, you will adhere to all departmental policies cited above, comply with all orders, and instructions given to you by ranking personnel (3.03, 3.05 & 3.07 of the Sheriffs Manual of Policy and Procedure) whether you agree with them, or not, unless illegal, or immoral. Being insubordinate and creating disharmony in the workplace is not acceptable and will not be tolerated.
