You are hereby notified that the Bexar County Sheriff's Office proposes to suspend you without pay for (5) days from the position of Deputy Sheriff - Law Enforcement for violation of the following:

Bexar County Sheriff's Office Civil Service Rule:

Chapter IX - Discipline/Disciplinary Action

Section 1. General

Subsection 9.02

(J.) - Poor job performance.

(P.) – Conduct which has proven to be detrimental or has an adverse effect on the Sheriff's Office.

By your actions, you are also in violation of the following rules and regulations in the Department General Manual of Policy and Procedure:

5.02 - Performance of Duties

5.24 - Conduct Unbecoming an Officer

6.10 - Reporting Incidents

#### Specifically, the reason for this action is:

On January 7th, 2015 at 1256 hrs, you were dispatched to 4326 Redtop Hill Drive for a criminal mischief report. While conducting your investigation, you attempted to open the hood of the vehicle in order to assess the damage in the engine compartment, but instead pulled the parking brake release. By doing so, the vehicle began to roll forward and subsequently came to a stop against the residence. Damage was caused to the vehicle and the house. After this occurred, you failed to report the damage or even your involvement which caused the damage.

Later that day, the Complainant (property owner) contacted PSI to report property damage and personal injury. The incident was not discovered until the PSI complaint was forwarded to the Patrol Division and you were confronted.

On March 18, 2015, I received notice that \$4,575 was paid for the damage to the house and truck.
