Commissioners and Fire Engineer Austin Cain:

Under and by the virtue of the authority vested in me by Chapter 143, Municipal Civil Service, Subtitle A, Title 5, V.T.C.A. Local Government Code, I do hereby suspend Fire Engineer Austin Cain from the San Antonio Fire Department without pay for an indefinite period, beginning on the 14 day of September

Fire Engineer Cain has violated Subsection C of Rule XIII of the City of San Antonio Fire Fighters and Police Officers Civil Service Commission Rules which were adopted on February 23, 1998, by the Fire and Police Civil Service Commission as the Civil Service Rules for the Fire and Police Departments of the City of San Antonio. The particular civil service rules violated by Fire Engineer Cain and which are grounds for suspension are as follows:

> Rule XIII, Subsection C(12): Violation of an applicable fire or police department rule, or special order.

The Rules and Regulations of the San Antonio Fire Department which Fire Engineer Cain has violated were those approved by the Firemen's and Policemen's Civil Service Commission on February 10, 2003, to be effective March 7, 2003. The particular rules thereof which Fire Engineer Cain has violated are as follows:

2.02 ABIDE BY LAWS AND DEPARTMENTAL ORDERS:

- ORDERS, RULES, REGULATIONS, DIRECTIVES, POLICIES B. AND PROCEDURES: Members shall abide by the Rules and roles and responsibilities, Departmental Regulations, administrative orders, directives, policies and procedures of the San Antonio Fire Department.
- REPORT OF ARREST, CRIMINAL CHARGE, OR INDICTMENT: Any 9.03 Member arrested, charged with or indicted for a federal, state (any state) or municipal offense (any municipality), must immediately provide the Office of the Fire Chief with written notification of such incident. The

Member must provide the Office of the Fire Chief with the name of the arresting agency, a description of the nature of the charges, the date of the incident and the style, court and cause number of the charge or indictment, if any. This rule does not apply to non-alcohol or non-drug related traffic citations or parking violations.

The acts committed by Fire Engineer Cain which violated the aforementioned Civil Service Rules and Fire Department Rules are as follows:

On or about March 28, 2016, Fire Engineer Cain was arrested for public intoxication by the San Antonio Police Department. An SAPD officer observed that his eyes were bloodshot/watery and he smelled strongly of an odor of alcoholic beverages. Fire Engineer Cain was also observed to have difficulty keeping his balance. After this incident, Fire Engineer Cain failed to report the incident to his supervisor in conformity with SAFD Rules and Regulations. Each day that he did not report this arrest was a violation of those Rules and Regulations. The San Antonio Fire Department became aware of Fire Fighter Cain's arrest on March 27, 2017. On May 5, 2017, Fire Fighter Cain provided a memorandum to Chief Hood acknowledging that he had failed to report.

Fire Engineer Cain's violation of the cited rules is the basis for these charges and the reason for his indefinite suspension without pay.

An original of this disciplinary suspension order is being filed with the Fire Fighters' and Police Officers' Civil Service Commission.

RELEASE AND SETTLEMENT AGREEMENT

SECTION 4. FIRE ENGINEER CAIN, FOR HIMSELF, HIS HEIRS, EXECUTORS, AND ASSIGNS, DOES HEREBY RELEASE, DISCHARGE, AND ACQUIT THE CITY OF SAN ANTONIO, TEXAS, ITS SUCCESSORS, ASSIGNS, OFFICERS, AGENTS, SERVANTS, AND EMPLOYEES, AND CHARLES N.
