


AGREED ORDER AND ENACTMENT OF SUSPENSION

EMPLOYEE: Deputy Samuel C. Garcia, Badge # 1973, 2nd Annex DATE: November 13, 2017



You are hereby notified that the Bexar County Sheriff's Office is suspending you without pay for a total of Three (3) business days, from the position of Detention Deputy.

Per IA# 2017-0218, you have violated the Bexar County Sheriff's Office Manual of Policy and Procedure Rules as follows:

5.53 Persons in Custody

The specific reasons for this action: On or about April 10, 2017, while off duty you met with a known Work Release Inmate to conduct business for financial gain. During an Internal Affairs Investigation you admitted to meeting and engaging the service of a known inmate in custody of the Bexar County Sheriff's Office. Your disregard for the Bexar County Sheriff's Office policy and procedures will not be tolerated.

The corrective action required: In the future you will remain cognizant that you represent the Bexar County Sheriff's Office, whether in an on or off duty status. You will refrain from fraternizing with anyone in the custody of the Bexar County Sheriff's Office. Be advised that a continuation of the action (or lack of action) that resulted in this Order of Suspension will result in more serious disciplinary action, including dismissal from the Sheriff's Office.

On October 25, 2017 you were served with a Notice of Proposed Suspension for ten (10) days, for the violations cited above. You requested a hearing, accordingly a grievance hearing was held on November 9, 2017 in my office.

Present at the hearing were the following:

Deputy Chief Laura M. Balditt, Adult Detention Bureau Laura Martinez, HR Technician Deputy Samuel Garcia, Grievant Morris Munoz, CLEAT Attorney

After hearing your case, I offered to reduce the Notice of Proposed Suspension (10 days) to an Agreed Order and Enactment of Suspension three (3) days. You have accepted the action therefore I am issuing this Agreed Order and Enactment of Suspension (3). Be advised that by agreeing to this reduced action you are also agreeing to waive further grievance and appeals procedures regarding this issue.

Accordingly, you will SERVE your Suspension in accordance with the 8 hour working schedule, which is currently in effect. Be advised that pursuant to Civil Service Rule 5.53, you may opt to forfeit leave up to a total of five (5) days, or the equivalent to forty hours, in one calendar year. If you choose to forfeit your accumulated leave you must complete the specific information requested on the document titled Request to Forfeit Leave in Lieu of Suspension.
