Commissioners and Battalion Chief Richard Giusti:

Under and by the virtue of the authority vested in me by Chapter 143, Municipal Civil Service, Subtitle A, Title 5, V.T.C.A. Local Government Code, I do hereby suspend Battalion Chief Richard Giusti from the San Antonio Fire Department without pay for a period of five days, beginning on the _______ day of ________, 2018.

Battalion Chief Richard Giusti has violated Subsection C of Rule XIII of the City of San Antonio Fire Fighters and Police Officers Civil Service Commission Rules which were adopted on February 23, 1998, by the Fire and Police Civil Service Commission as the Civil Service Rules for the Fire and Police Departments of the City of San Antonio. The particular civil service rules violated by Battalion Chief Giusti and which are grounds for suspension are as follows:

Rule XIII, Subsection C(12): Violation of an applicable fire or police department rule, or special order.

The Rules and Regulations of the San Antonio Fire Department which Battalion Chief Giusti has violated were those approved by the Firemen's and Policemen's Civil Service Commission on February 10, 2003, to be effective March 7, 2003. The particular rules thereof which Battalion Chief Giusti has violated are as follows:

- 2.02 ABIDE BY LAWS AND DEPARTMENTAL ORDERS:
 - B. ORDERS, RULES, REGULATIONS, DIRECTIVES, POLICIES AND PROCEDURES: Members shall abide by the Rules and Regulations, Departmental roles and responsibilities, administrative orders, directives, policies and procedures of the San Antonio Fire Department.
- 10.06 RESTRICTIONS ON ACTIVITIES WHILE SICK, INJURED, OR ON LIMITED DUTY:

- REMAIN AT RESIDENCE: Members, while on A. sick or injury leave, shall remain at their place of residence unless absence from their place of residence is authorized by Department policy.
- REPORTING FOR DUTY WITH ILLNESS OR D. INJURY: Members shall not report to duty unless they are free from any illness, injury, or condition that would in any way impede their ability to perform the duties required of their position. Neither shall members remain on duty if they become ill or injured during a tour of duty to the extent that said injury or illness will impede their ability to perform the duties required of their position.

The acts committed by Battalion Chief Giusti which violated the aforementioned Civil Service Rules and Fire Department Rules are as follows:

On or about Sunday, October 15th, 2017, while on sick leave, Battalion Chief Giusti visited Fire Station 19 to check up on the staff and specifically, how his newly assigned Incident Command Technician was adjusting to his role. During this visit, Battalion Chief Giusti was informed about an airport exercise that was to be conducted at San Antonio International Airport. Despite the fact that he was on sick leave, on Wednesday, October 18th, 2017, he came into work and participated in the exercise. Additionally, Battalion Chief Giusti failed to notify anyone that he was not cleared for duty, disregarded the rules, regulations, and operational procedures in place. His actions tend to bring reproach upon himself and the San Antonio Fire Department.

Battalion Chief Giusti's violation of the cited rules is the basis for these charges and the reason for his five day suspension without pay.

An original of this disciplinary suspension order is being filed with the Fire Fighters' and

Police Officers Civil Service Commission.
