## AGREED SUSPENSION

Commissioners and Officer Samuel Cortez:

WHEREAS, Officer Samuel Cortez, pursuant to Article XXVIII, Section 2 of the Collective Bargaining Agreement by and between the City of San Antonio and the San Antonio Police Officers' Association, was served on May 23, 2018, with a one-day contemplated suspension; and

WHEREAS, pursuant to said contract, Officer Cortez was given an opportunity to rebut those charges being brought against him to Police Chief William P. McManus; and

WHEREAS, said opportunity was exercised by Officer Cortez; and

WHEREAS, Officer Cortez and his captain, Tracy Powers, have agreed and Chief McManus has approved of settling this matter with a one-day suspension without pay; NOW THEREFORE:

The undersigned parties hereby enter into this suspension agreement wherein it is provided that Officer Cortez shall be suspended without pay from the San Antonio Police Department for a period of one day, commencing on June 17, 2018, and ending on June 17, 2018. Officer Cortez waives any rights to appeal this Agreed Suspension and agrees no administrative or judicial body shall have power to review this Agreed Suspension or alter the terms of this agreement.

Officer Cortez has violated Subsection C of Rule XIII of the City of San Antonio Fire Fighters' and Police Officers' Civil Service Commission Rules, said rules having been adopted on February 23, 1998, and thereafter from time to time amended, by the Fire Fighters' and Police Officers' Civil Service Commission as the Civil Service Rules for the Fire and Police Departments of the City of San Antonio. The particular civil service rules violated by Officer Cortez and grounds for suspension are as follows:

(12) Violation of an applicable fire or police department rule or special order.

The Rules and Regulations and Procedures of the San Antonio Police Department which Officer Cortez has violated are as follows:

PROCEDURE 917 - FIESTA AND SPECIAL EVENT ASSIGNMENTS (.04) FIESTA EVENTS (C) Attendance Requirements (1) Officers committing to Fiesta event assignment(s) and failing to report for duty are carried as "unauthorized absence from duty".



The factual basis for the instant disciplinary suspension is as follows:

On or about April 19, 2018, Officer Samuel Cortez was absent for his scheduled Fiesta assignment.

I further acknowledge that in light of my entry into this Agreed Suspension, I shall have no right to appeal said suspension nor will any administrative or judicial body have power to review same or alter its terms. I do hereby waive any and all rights to appeal said suspension and no administrative or judicial body shall have power to review same or alter its terms.
