## AGREED SUSPENSION

Commissioners and Officer Amanda R. DeHoyos:

WHEREAS, Officer Amanda R. DeHoyos, pursuant to Article XXVIII, Section 2 of the Collective Bargaining Agreement by and between the City of San Antonio and the San Antonio Police Officers' Association, was served on July 21, 2018, with a one-day contemplated suspension; and

WHEREAS, Officer DeHoyos and her captain, Tracy Powers, have agreed and Chief McManus has approved of settling this matter with a one-day suspension without pay; NOW THEREFORE:

The undersigned parties hereby enter into this suspension agreement wherein it is provided that Officer DeHoyos shall be suspended without pay from the San Antonio Police Department for a period of one day, commencing on August 30, 2018, and ending on August 30, 2018. Officer DeHoyos waives any rights to appeal this Agreed Suspension and agrees no administrative or judicial body shall have power to review this Agreed Suspension or alter the terms of this agreement.

Officer DeHoyos has violated Subsection C of Rule XIII of the City of San Antonio Fire Fighters' and Police Officers' Civil Service Commission Rules, said rules having been adopted on February 23, 1998, and thereafter from time to time amended, by the Fire Fighters' and Police Officers' Civil Service Commission as the Civil Service Rules for the Fire and Police Departments of the City of San Antonio. The particular civil service rules violated by Officer DeHoyos and grounds for suspension are as follows:

(12) Violation of an applicable fire or police department rule or special order.

The Rules and Regulations and Procedures of the San Antonio Police Department which Officer DeHoyos has violated are as follows:

RULE 3.04 - RESPONSIBILITY TO SERVE THE PUBLIC (B) COURTESY: Members shall at all times be courteous, kind, patient, and respectful in dealing with the public, and shall strive to merit the esteem of all law abiding citizens by an impartial discharge of their official duties.

The factual basis for the instant disciplinary suspension is as follows:

On or about June 15, 2018, Officer Amanda R. DeHoyos met up with Officer Ralph Gomez after completing separate calls. Officer Gomez advised Officer DeHoyos about a female from his call who had given him a personal phone number while at the Silver Creek Apartments. During Officer DeHoyos' conversation with Officer Gomez, she was informed that the aforementioned female had suggested a dinner meeting with Officer Gomez and had touched him. A short time after Officer DeHoyos' meeting with Officer Gomez, Officer DeHoyos phoned the manager of the Silver Creek Apartments and made numerous accusations towards the manager, believing she was the person in question. Officer DeHoyos accused the manager of flirting with Officer Gomez and warned the manager that she was going to call the Silver Creek Apartments complex's corporate office to file a complaint against this manager for sexual harassment. In the investigation of this incident, it was discovered that the manager in question was not the party who had spoken to Officer Gomez. The actions taken by Officer DeHoyos brought embarrassment to herself, the Northwest Substation, and the San Antonio Police Department.
