Summary of Incident

Summary of How the Death Occurred: (max. 30,000 characters)

Summary:

On August 31st 2018 at 1127hrs SAPD Officer Rodriguez arrived at 5910 Royal Gate apartment number 320 for a disturbance. The callers told police dispatch they could hear someone yelling and possibly throwing things in apartment 320. Officer Rodriguez arrived on scene and knocked on the door of apartment 320.

Officer Rodriguez heard a male voice sounding threatening. Officer Rodriguez backed away from the door and Pete Sanchez later exited. Pete Sanchez was armed with a metal pipe in one hand and a large kitchen knife in the other. Officer Rodriguez ordered Pete to drop the weapon and Pete acknowledged Officer Rodriguez presence, then advanced. Officer Rodriguez pulled his duty issue firearm and fired three times in the direction of Pete Sanchez. Pete Sanchez was shot twice and walked back into his apartment. Officer

Rodriguez maintained a safe distance from Pete Sanchez until the assistance from other officers arrived. Officer Rodriguez administered first aid (tourniquet to left thigh) and Pete Sanchez was then transported to the hospital by EMS. On 09/01/2018 Pete Sanchez was pronounced deceased at 1548hrs by hospital staff.
