## MOTION TO REVOKE COMMUNITY SUPERVISION

## TO THE HONORABLE JUDGE RON RANGEL:

Now comes the Criminal District Attorney of Bexar County, Texas and would show the Court that the Defendant in the above styled and numbered cause was found guilty of the offense of DRIVING WHILE INTOXICATED-3D/MORE, and was placed on probation by the Court on the 24th day of October, 2018, for a term of 6 Years under the provisions of the Adult Probation and Parole Law as reflected by said Judgment entered herein;

That thereafter, during the term of said probation, the Defendant violated the terms and conditions therein in the following particulars, to-wit:

VIOLATED CONDITION NO. 2: On or about the 6th day of December, 2018, in Bexar County, Texas, the defendant, James Preston Green, did then and there consume alcoholic beverages, in violation of Condition No. 2.

VIOLATED CONDITION NO. 17: On or about the 7th day of December, 2018, in Bexar County, Texas, the defendant, James Preston Green, did then and there fail to comply with the rules, regulations, or instructions of Ignition Interlock, in that the defendant recorded a high BrAC of 0.057 at 11:41 am, in violation of Condition No. 17.

VIOLATED CONDITION NO. 17: On or about the 7th day of December, 2018, in Bexar County, Texas, the defendant, James Preston Green, did then and there fail to comply with the rules, regulations, or instructions of Ignition Interlock, in that the device went into LOCKOUT STATUS at 11:41 am, in violation of Condition No. 17.

VIOLATED CONDITION NO. 17: On or about the 7th day of December, 2018, in Bexar County, Texas, the defendant, James Preston Green, did then and there fail to comply with the rules, regulations, or instructions of Ignition Interlock, in that the defendant recorded a warning BrAC of 0.012 at 01:03 pm consistent with Alcohol use, in violation of Condition No. 17.

VIOLATED CONDITION NO. 20: On or about the 7th day of December, 2018, in Bexar County, Texas, the defendant, James Preston Green, did then and there fail to comply with the rules, regulations, or instructions of Soberlink, in that the defendant recorded a positive BrAC of 0.054 at 09:53 am consistent with Alcohol use, in violation of Condition No. 20.

Premises considered, therefore, the Criminal District Attorney, Bexar County, Texas, moves the Court to cause a warrant to be issued for arrest of said defendant, and that upon his arrest hearing be held and probation revoked in this cause, as the evidence and judgment of the Court thereon may warrant.
